In the heart of Sarpy County lies a commitment to caring for one another, especially during times of need. NeighborGood: a Community Pantry (NeighborGood) is a 501c3 nonprofit organization which has been serving as a beacon of hope, providing essential support to families facing food insecurity for over 15 years.

MEETING COMMUNITY NEEDS

Since its inception, NeighborGood has played a crucial role in addressing food insecurity, serving hundreds of families each month.

Poverty is considered the single largest determinant of health and wellbeing because it creates barriers to accessing resources, including health services, healthy foods, and other necessities that contribute to health. In 2020, about 5.6% of Sarpy County residents lived below the federal poverty level, and 10.9% were food insecure, a common metric to measure poverty status.

Soaring inflation, living expenses, and food prices have compounded the situation. Since 2021, NeighborGood has seen an average annual increase of 38% in guests needing our services. We anticipate this demand will only continue to grow.





neighborgood limitations

As the demand for our services increased, we found ourselves facing significant challenges to meet those needs. Our previous space was inadequate to address the increasing demand for services. The limited space restricted our ability to acquire, store and distribute food efficiently, resulting in delays and shortages for those in need. Additionally, the outdated infrastructure posed safety concerns for our volunteers and guests.

NeighborGood's previously leased space was not designed for food distribution and lacked the ability to expand. The location had many deficiencies including:

- Inability to become guest choice and give families the ability to "shop" in a guestfriendly, grocery style type of pantry to obtain products they will use and need
- Limited warehouse space to receive shipments and distribute goods
- Extremely limited dry goods storage and sorting space
- Inadequate refrigeration units to accommodate frozen foods, fresh produce, milk, eggs, cheese and other products



NeighborGood has purchased a building, to become our permanent home, enabling us to expand our capacity to serve to ensure that no family goes hungry.

To eliminate hunger in our community by providing neighbors in need with nutritious food, increased self-sufficiency, and hope.


OUR VISION

NeighborGood, centrally located within the county, serves as a pantry and distribution point for essential items following natural disasters. Our new facility, specifically designed and equipped for these purposes, will enable us to reach and serve our guests more efficiently and effectively.

- Flexibility and capacity to become a Point of Distribution (POD) and Emergency Operations Center (EOC) for crisis response



An updated facility for NeighborGood is imperative to address the following critical needs:

CAPACITY EXPANSION

The new facility will provide NeighborGood with the space needed to store a larger inventory of food items and accommodate more guests. This expansion is crucial to keep pace with the growing demand for services and ensure that no individual or family in our community goes hungry.

ENHANCED EFFICIENCY

With modern facilities and storage systems, operations will be streamlined, ensuring that food is efficiently sorted, stored, and distributed to those in need. This will enable us to serve more guests in less time, reduce wait times, and allow us to serve our guests with the dignity and respect they deserve.

SUSTAINABILITY

We envision our facility as a model of sustainability, incorporating energy-efficient technologies and environmentally friendly practices to minimize expenses and reduce longterm operating costs.

SAFETY AND SECURITY

The new facility, with modern safety features, will create a secure environment for our volunteers, staff, and guests, fostering a sense of trust and confidence in our services.

IMPROVED ACCESSIBILITY

The new facility will be fully accessible to individuals with disabilities, ensuring that everyone in our community can access the support they need. This commitment to inclusivity aligns with our values of equity and compassion.

challenges and solutions neighbor



NeighborGood's current operating space limits its ability to serve the diverse needs of the guests who use NeighborGood's services.

Challenges	Solution Within Proposed Project
Guests are not able to do their own personal shopping due to our limited space. As a result some families end up receiving items they cannot use, creating food waste.	
Lack of refrigerator and freezer space prohibits NeighborGood's ability to participate in sustainable food rescue and limits the types of cold and perishable foods we can accept as donations and offer to guests.	Will have space for large walk-in refrigerators/freezers. This will expand our ability to provide milk, eggs, and cheese on-site as well as provide more fresh fruits, vegetables, and other cold items that are donated.
Limited space results in NeighborGood turning down large volunteer groups. We need volunteers but cannot accommodate more than a few at a time.	Will allow for corporate and community volunteer groups to support our efforts in much larger numbers.
Our service offerings to our guests are limited due to restrictions of the current building, such as the hours of service, size of our leased space, parking lot limitations, and outdoor usage limitations.	 Will allow us to manage our own hours and initiatives at our discretion. We will be able to host: Health and vaccination clinics Nutritional services WIC/SNAP advising Point of Distribution for the County following natural disaster Private consultation rooms
The current donation drop off area is also where guests pick up their pantry items.	Will have a separate entrance for donation drop off and a loading dock which allows for uninterrupted intake of donations during guest hours. Guests will enter through the front door.
Our current location only has a small community garden.	Will allow for expansion of our community garden, edible landscaping and composting.

MEETING COMMUNITY NEEDS

NeighborGood plays a crucial role in addressing food insecurity in Sarpy County. We serve hundreds of families each month including residents of Papillion, La Vista, Ralston, Bellevue, Gretna, Springfield and local rural areas.

NEIGHBORGOOD LIMITATIONS

The previously leased facility was inadequate to address the rising demand for services. We were restricted in our ability to operate efficiently.

Cash, Check, Bank Transfer, Credit Cards

Donors who contribute with credit cards may add a percentage to cover processing fees.

Stocks

Save on capital gains and income taxes. Deduct the value of the stock at current market rates regardless of your original purchase price.

Qualified Charitable Distributions from an IRA/RMD

Those over 70.5 years of age can make charitable donations paid directly to NeighborGood from their IRA account and avoid personal income tax liabilities. Individuals 72 years of age and older may consider making their required minimum distribution (RMD) payable to NeighborGood.

Real Estate

A gift of real estate to NeighborGood can be accomplished by working with staff and advisors prior to making a transfer. Gifting real estate offers tax advantages, avoids capital gains, and allows you to claim the current fair market appraised value of your property as a tax deduction.

Naming Opportunities

Make a lasting tribute with a legacy gift.

Donor Advised Fund

Charitable contributions to your donoradvised fund can be transferred by submitting NeighborGood information to your fund representative.

Pledges

Making a two or three-year pledge to NeighborGood can spread your gifts over time.

Naming Rights to the New Building

Neighbor Shopping Area

A grocery store setup for guests to select items for their family. It will include passthrough refrigerators/freezers for dairy and protein items, food and paper products on store shelving, and fresh produce displays.

Operations Center and Inventory Control

This control center is where donated items will be sorted, processed, and prepared for distribution. It will track food and products annually, including food donated by individuals, retailers, manufacturers, food service companies, farmers, and other commodities.

Community Training and Conference Room

The Community Training and Conference Room will serve as a central meeting space for staff, volunteers, guest education programs, and clinics. This informal meeting area will foster collaboration among our staff and partners and enhance our service to the community. Additionally, it will provide a space where guests can use provided computers to sign up for services or benefits.

Welcome Center

The welcome desk and guest waiting area will host thousands of volunteers and visitors each year. This space is equipped with a comfortable seating area, restrooms, and kids' activity area.

Refrigeration/Freezer Unit

Walk-in refrigeration & freezer units to provide cold storage space for fresh produce from our community garden and edible landscaping, donations of surplus items, dairy products, and various frozen protein options.

Dock & Distribution Hub

The central entry and exit point for large food donations, and deliveries.

Community Garden

A sustainable solution for providing in-season produce.

Donation Dropoff Zone

A covered drive-up area for smaller donations from individuals and food drives.

Pet Food Pantry

A pantry area for items important to the family members with fur.

Perishable Food Processing Area

A clean room for volunteers to process and package produce.
